PREVENTIVE MEASURES AND ACTION AGAINST GENDER-BASED VIOLENCE

STATEMENT OF PRINCIPLES

Malaga Festival, willing to promote a safe festival free of any kind of violence. The festival will not tolerate any kind of behaviours that threatens the physical or psychological integrity or the dignity of people, whether for reasons of sex, gender, orientation, class, origin, race, cultural level, etc.

The Malaga Festival is also particularly sensitive to any kind of manifestation of sexist violence.

For all these reasons, Malaga Festival will take the necessary measures to deal with any kind of violence.

GENERAL MEASURES

- Participants, guests, jury, collaborators, etc. will be informed of the current protocol and of the fact that simply taking part or attending the Malaga Festival implies their acceptance of it.
- The whole organisation, aware of the protocol, has been instructed to immediately inform those in charge of the organisation of any type of violent behaviour, in any of the areas in which our activities take place.
- Malaga Festival will investigate and hear the parties and will take appropriate measures to address any problems with due diligence. Such measures may include mediation between the parties up to expulsion and prohibition from participation in the entire activity, with Malaga Festival reserving the right to act unilaterally, if necessary, with or without the consent of the parties.

SPECIFIC MEASURES AGAINST GENDER-BASED VIOLENCE

- To raise awareness, prevent and assist victims of gender violence, there will be information about available resources for information, counselling, and intervention in the different spaces and activities where Malaga Festival carries out its activities.
- In sensitive activities at the Malaga Festival, the availability of professionals trained in sexual assault and harassment will be made known. The Festival will set up a telephone number for incidents.
- Malaga Festival is committed to:
 - Respect and protect the privacy and dignity of the people concerned.
 - Maintain all questions or complaints confidential; people involved in the application of the protocol must observe the duty of silence.
 - Act with diligence and professionalism; provide trained professionals for the application of the protocol.
 - Avoid re-victimisation through unnecessary repetition of the story or public disclosure of data.
 - Restore the complainant's previous situation, ensuring that the victim has no contact with the aggressor.
 - Avoid reprisals against complainants or witnesses.

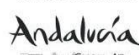
